FOLLOW-UP REPORT OF A SECONDARY PHYSICIAN

The patient is returning to my attention following her previous clinical visit on October 8, 2021. She is now status post medical-legal evaluation later during the month of October. We look forward to that report as it becomes available.

Physical examination again showed spasm, tenderness, and guarding in the paravertebral musculature of the cervical and lumbar spine. There is a decrease in sensation noted in the left C6 and right L5 dermatomes. The left shoulder had impingement and Hawkins signs with range of motion in flexion and abduction to approximately 120 degrees. The right knee has patellar crepitus on flexion and extension with medial joint line tenderness.

Current medications will be refilled.

Modifications for work will be deferred to the primary treating physician.

The patient will return to my attention in eight weeks.
