

On October 14, 2019 you failed to read a message in TCP requesting you to see the accounting department regarding completing a DBR. On October 15, 2019 as you were meeting with La Shonda, I received a call for Tonia and all I could hear was you yelling in the back ground. As I came up stairs, I informed you to complete your DBR and you stated that you were being threaten by the message in TCP. Ms. Garner as you were leaving the office you made an inappropriate comment stating all this security Shit! You are also reminded that MST LA does not tolerate any intentional or unintentional acts of hostile, offensive, work environment.

Our investigation has determined that your conduct is inappropriate behavior in violation of the Company policy. Your disciplinary action is unpaid suspension for your P.M. shift on October 15, 2019.

Any further violations of this nature will result in further disciplinary action, and / or Suspension, up to including termination.



**REQUIRED STANDARDS:**

All MST employees are expected to follow professional conduct standards and we believe that individuals selected to fill our positions already have a good understanding of appropriate work behavior. We believe in a positive environment where doors are open for achievement and individual differences are accepted. However, at every work place some rules about conduct are necessary for the orderly operation of business and to protect the rights of other employees.

As I walked in I ask Ms. Garner what was the problem and to calm down. LaShonda is just trying to get you to complete your DBR's. She replied whats all this, I said what? You brought all this security with you. I turned around and looked to see JT and Floyd behind me. I replied Ms. Garner they are not security, they are my staff. She then stated I don't like being threaten,I then replied Ms. Garner you are not being threaten, just fix your DBR and your done, she wasn't listening and became very angry and upset and as she was exiting the accounting department door, she stated I don't believe all this security SHIT! Yelling, with very inappropriate behavior, attitude,as she was walking down the stairs. As I was returning to my office I heard Ms. Garner yelling out in the drivers room and acting very inappropriate telling the driver what happen upstairs. So I walked in the driver room and I replied to Ms. Garner Please! don't air out your personal business in front of the drivers. She replied and said something like I can tell whoever I want, You brought in all of your security SHIT! I replied okay thats enough you can go home for the day.**

On 10/15/2019 @ approximately 9:50 am during a manager's meeting with my boss Reggie Young and Floyd Trice. A call from La Shonda, I could hear loud talking without clarity over the phone. Based on Reggie's reaction I knew there was something wrong. He did not have time to discuss the matter with us and exits the office heading upstairs. I followed behind him with urgency.

I followed Reggie into payroll office, Ms. Garner was standing in front of the cubicle next to La Shonda. Reggie asked Ms. Garner "what was the problem and to please calm down". Ms. Garner, stated "You Brought All This Security with You!" Ignoring the question. Reggie explains to her that they are not security. Ms. Garner stating, "I feel threatened!", All This Security SHIT!" exiting the office and heading down stairs.

I returned down stairs with Reggie thinking to continue our previous meeting. As we both returned down stairs and passing the driver break room, we heard Ms. Garner talking to anyone that will listen about the incident upstairs, Reggie enters the break room and addresses the issue asking her to not " Air Out Your Personal Business In Front Of The Drivers" I did not hear her next reply but, Reggie stated " Enough You Can Go Home for The Day ".
