Dear Drs. White and Mourani,

I saw Daniel Doran (dob: 6/4/66) today after seeing him in consultation for leukocytosis on 2/7/12. He had a number of labs done to further characterize this. Please see the enclosed labs from LabCorp done on 2/22/12 for the complete report. Of note his WBC was 12.5 (4.0-10.5), the differential was all within normal limits. His CMP revealed a glucose of 289 and ALT of 67 (0-55). The rest of the CMP was normal. BCR/abl was negative as was the JAK-2. Folate, Vitamin B12, ferritin, iron studies, retic ct were all normal. ESR was 1 and CRP wass 1.2, both at the lower limit of normal.

At this point, his leukocytosis (288.60) appears not to be due to a hematologic problem, ie he does not have evidence of a primary bone marrow problem such as AML, MDS, CML or other MPD. I do think continued follow up is indicated to assure stability and Mr. Doran is comfortable with this plan. I will see him in 2 months and if his CBC remains stable I will increase intervals between visits.

Dear Drs. White and Mourani:

Thank you very much for referring Mr. Daniel Doran for hematology consultation. As you know, he is a 45-year-old plumber with a recent history of leukocytosis. He tells me it was first discovered in September when he was being seen because he wasn't feeling well and was weak like a "wet noodle," but besides that, no other specific complaints. He tells me his appetite has decreased a bit but not hugely. He has been trying to eat more healthfully. He has lost 15 pounds over the last four months, primarily from change in diet and not eating quite so much, which change he has attributed to his girlfriend. His energy level is moderately decreased as noted above, and this is his main complaint. No fevers, chills, sweats, nausea, vomiting, headaches, rapid change of vision. He does have some sweats when his gout is active and his diabetes is out of control but nothing severe. No new lumps or bumps.

ALLERGIES: None.

MEDICATIONS: Allopurinol, colchicine, various antibiotics of late, and as of last week he has been on prednisone for his gout, which is now resolved and is currently not active.

PAST MEDICAL HISTORY: Gout, diabetes mellitus, sweats when sugars are out of control. In 2006 he underwent bilateral mastectomies. Reviewing the pathology from Methodist Hospital, it was not actually mastectomies but bilateral breast tissue was removed, presumably from gynecomastia, which was becoming irritating and painful, especially while he was working.

FAMILY HISTORY; His father died of complications from diabetes mellitus with a CVA at age 78. He did have a history of colon cancer. His mother died at age 82 from complications of an infection.

SOCIAL HISTORY: He is widowed. His wife committed suicide in 2002. He has no children. His wife had four children, the youngest of which is living with his father. He has been dating someone for the last four years and is currently\_living with her in a one-story house with two steps to enter. Occasionally her adult daughter lives with them. Tobacco: Less than one pack per day for 30 years. Alcohol: Rare for the last-three-years, occasionally he will have a glass of wine with his wife. Prior to that he drank quite heavily, culminating three years ago with drinking a quart of vodka a day. He realized this was not healthy for him, and he quit drinking so much. He has a pet dog who weighs 45 pounds. He works as a plumber.

REVIEW OF SYSTEMS: Sweats that occur when his diabetes mellitus is out of control, which he usually controls by diet, and occasionally when his gout is out of control. Otherwise as per HPI, or is otherwise negative.

PHYSICAL EXAM: He is a well-developed, well-nourished white male looking to be healthy and vibrant.

VITAL SIGNS: Weight 179 pounds. Height 71". Pulse 94. O<sub>2</sub> saturation on room air 98%.

HEENT: Normocephalic, atraumatic. Pupils are equal, round and reactive to light. Sclerae are anicteric. Conjunctivae are normal pink without petechiae. Extra ocular muscles are intact. Ears externally normal with normal hearing. Nose externally normal with normal nares. Mouth is unremarkable.

NECK: Supple, full range of motion.

LYMPH NODES: None palpable in the neck, supractavicular, axillary or inguinal areas.

BACK: 'Non-tender.

ABDOMEN: Soft and non-tender, non-distended. Liver is palpable on deep inspiration but the backs.

NEURO/PSYCH: Alert and oriented. Normal mood and affect. Ambulatory without abnormality. No obvious focality noted.

LABORATORY DATA: January 17th, white count 16.3, hematocrit 46.6, MCV 91, RDW 13.0, platelet count 254,000, differential is all within normal limits, neutrophils are normal at 6, lymphs 4.2, monos 0.9, eos 0.1. Of note, upper limit of normal of white blood cell count is 10.5. December 7, 2011 white count was 12.0, differential all within normal limits. At that time, BMP and hepatic function panel, except for a glucose of 145, were all within normal limits. September 23, 2011, white count 13.1, differential unremarkable. July 22, 2011, white count 12.1. January 11, 2011, white count 11.6, with what appears to be normal differential.

IMPRESSION: This is a 45-year-old gentleman with mild leukocytosis but normal differential. He does have a history of gout and diabetes mellitus. Gout may be present at a chronic low level causing mild stimulation of his white cells, causing them to be mildly elevated. In addition, patients with diabetes mellitus frequently have chronic infections at a subacute level and this may be causing mildly elevated white blood cell count. I have asked that he stop his prednisone soon, wait at least one week, get some labs done, and return to see me one week later. These labs are to include CMP, CBC, BCR-ABL qualitatively, iron studies including ferritin, JAK2, reticulocyte count, ESR, C-reactive protein, vitamin B<sub>12</sub>, folic acid levels. Depending on these results, further evaluation will be considered. At this point, it appears to be a benign process but again we will await labs for further interpretation.

Dear Dr. White:

I saw Mr. Doran in followup. As you recall, I gave him Augmentin after his last visit and asked him to repeat his CBC, which continues to show leukocytosis. He mentioned that his abdominal pain is slightly better, but he still has some lower abdominal discomfort and constipation for which he uses Bentyl with some improvement.

PHYSICAL EXAMINATION: Vitals are normal. Weight 184 pounds. Abdomen is soft with periumbilical and left lower quadrant abdominal tenderness.

#### IMPRESSION:

- 1. Lower abdominal pain, likely functional and related to irritable bowel syndrome. The patient has diverticulosis, but there is no evidence of diverticulitis on colonoscopy or CT scan.
- Persistent leukocytosis without response to antibiotics. suspect bone marrow pathology should be excluded.

RECOMMENDATIONS: I asked the patient to continue Bentyl. suggested fiber supplements on a regular basis. I referred him to see Dr. Polonsky for further evaluation of his mild leukocytosis. He will follow up with me in 6-8 weeks.

Dear Dr. White:

I saw Mr. Doran in followup. He continues to report left lower quadrant abdominal pain. The pain is intermittent without clear relieving or exacerbating factors. He also reports mild constipation. He tried trazodone, but that is causing lethargies, so he is not complaint with it. He mentioned that Bentyl offers some help. He denies any rectal bleeding.

PHYSICAL EXAMINATION: Vitals are normal. Weight is 182 pounds. Abdomen is soft with left lower quadrant abdominal tenderness.

Recent CT scan showed mild diverticulosis without obvious diverticulitis.

Laboratory data continues to show mild leukocytosis.

Persistent complaint of left lower quadrant IMPRESSION: abdominal pain associated with mild leukocytosis, although the patient had no obvious diverticulitis on CT scan. of possibility mild diverticulitis cannot be completely excluded.

RECOMMENDATIONS: I suggested a course of Augmentin 875 mg twice a day for 10 days and also probiotics. I asked the patient to have a CBC done towards the end of the treatment and then followup with me in two weeks. I would like to see his white count decrease with above treatment. If leukocytosis persist treatment, then further evaluation above hematological consultation will be required. I will keep Modi informed any further recommendations.

I saw Mr. Doran in followup. He is now reporting intermittent symptoms of abdominal pain occasionally in the periumbilical area and occasionally in the left side of the abdomen with some radiation to the back. There are also some reports of bloating and constipation. He denies any rectal bleeding. He denies any diarrhea or tenesmus. He denies any weight loss. He tried Bentyl, which tends to help his symptoms, but causes lethargy.

PHYSICAL EXAMINATION: Vitals are normal. Abdomen is soft with periumbilical left-sided tenderness.

**IMPRESSION:** Symptoms are likely related to irritable bowel syndrome.

RECOMMENDATIONS: The patient was reassured. I suggested trazodone 50 mg nightly. I ordered routine laboratory tests and a CT scan of the abdomen and pelvis to exclude any other significant pathology as a cause of his presentation. He will follow up with me in about three or four weeks. I asked him to keep me informed of his progress and any significant change in status.

Dear Dr. White:

I saw Mr. Doran in followup. As you know, colonoscopy done six days ago showed a polyp in the proximal ascending colon, which was removed. The patient also was noted to have diverticulosis and internal hemorrhoids.

The patient is here for followup. Apparently, he woke up early in the morning yesterday with severe cramps and has been having significant problem with loose stools, tenesmus, and frequency. He also noticed some blood in the stool. He denies any nausea or vomiting. He denies any fever.

PHYSICAL EXAMINATION: Vitals are normal. Abdomen is soft with left-sided and periumbilical abdominal tenderness.

#### IMPRESSION:

- 1. Adenomatous colon polyp and family history of colon cancer.
- 2. Diverticulosis coli.
- 3. Diarrhea, tenesmus, and blood in the stool are likely related to Clostridium difficile colitis. The patient received ciprofloxacin recently and I suspect his presentation is most consistent with Clostridium difficile colitis. Diverticulitis should be kept in mind as a cause of this presentation, but I suspect this is less likely.

I ordered stool for Clostridium difficile toxin. I asked the patient to call me after he does the stool test to discuss results and to update me on his progress. I also asked him to call me immediately if he notices worsening symptoms over the next 24 hours. I told the patient to expect improvement within the next 24-48 hours and complete resolution of symptoms within the next week.

The patient was advised to have a followup colonoscopy in three years.

Thank you for asking me to see Mr. Doran. As you know, he is a 45-year-old man referred because of abdominal pain and family history of colon cancer. For the past two months, the patient has had intermittent pain in the left lower quadrant area without clear relieving or exacerbating factors. He describes associated constipation. He denies any rectal bleeding, although reports having some rectal bleeding about a year ago that resolved. He denies any fever. He was recently started on ciprofloxacin and metronidazole with minimal improvement. Recent laboratory tests showed mild leukocytosis.

The qualitative RT-PCR assay is negative for the e1a2 (p190) and b2a2/ b3a2 (p210) fusion gene transcripts. These results also do not rule out the presence of low levels of BCR-ABL1 transcripts below the level of detection of this assay, or the presence of rare transcripts not detected by this assay.

#### Additional Information:

The BCR-ABL1 fusion is found in virtually all cases of CML and in 15-30% of cases of ALL. This fusion gene is usually formed by a (9;22)(q34;q11.2) translocation, resulting in the fusion of the breakpoint cluster region (BCR) on chromosome 22 with the Abelson protooncogene (ABL1) from chromosome 9. The derivative chromosome 22 of this translocation is known as the Philadelphia chromosome. In the majority of CML patients, the breakpoint in the BCR gene is located in a 5.8kb region spanning five exons, b1-b5 (exons 12-16), the major breakpoint cluster region (M-bcr). Most commonly, the breakpoint occurs in the introns following b2 or b3, which join with ABL1 exon 2 (a2), forming the fusion transcript b2a2 or b3a2. These chimeric transcripts encode a 210kDa BCR-ABL1 fusion protein, referred to as p210. In approximately 3% of CML cases, this gene fusion occurs without cytogenetic evidence of the rearrangement. In approximately 75% of Philadelphia positive ALL patients, the breakpoint in the BCR gene is located within intron 1, at the minor breakpoint cluster region (m-bcr). Exon 1 (el) of BCR joins with the ABL1 a2, forming the fusion transcript ela2, encoding a 190kDa BCR-ABL1 fusion protein referred to as p190. Comment: The principle use of this qualitative test is to confirm the presence of the BCR-ABL1 fusion gene transcript and to identify the particular breakpoint(s) present. Fluorescent in situ hybridization (FISH) and/or quantitative RT-PCR is recommended for quantitative post-therapy residual disease monitoring.

Total RNA was isolated from the provided specimen and subjected to reverse transcription-polymerase chain reaction (RT-PCR). #### JAK2 V617F mutation detection

Result: NEGATIVE for the JAK2 V617F mutation. Interpretation: The G to T nucleotide change encoding the V617Fmutation was not detected. This result does not rule out the presence of the JAK2 mutation at a level below the sensitivity of detection of this assay, or the presence of other mutations within JAK2 not detected by this assay. This result does not rule out a diagnosis of polycythemia vera, essential thrombocythemia or idiopathic myelofibrosis as the V617F mutation is not detected in all patients with these disorders.

#### Background:

JAK2 is a cytoplasmic tyrosine kinase with a key role in signal transduction from multiple hematopoietic growth factor receptors. point mutation within exon 14 of the JAK2 gene (G1849T) encoding a valine to phenylalanine substitution at position 617 of the JAK2 protein (V617F) has been identified in most patients with polycythemia vera, and in about half of those with either essential thrombocythemia or idiopathic myelofibrosis. The V617F has also been detected, although infrequently, in other myeloid disorders such as chronic myelomonocytic leukemia and chronic neutrophilic leukemia. V617F is an acquired mutation that alters a highly conserved valine present in the negative regulatory JH2 domain of the JAK2 protein and is predicted to dysregulate kinase activity. Methodology:

Genomic DNA was purified from the provided specimen. Allele-specific PCR using fluorescent primers was used to simultaneously amplify both the wild type and mutant alleles. Amplification products were analyzed by capillary electrophoresis. This assay has a sensitivity to detect approximately a 5% population of cells containing the V617F mutation

in a background of non-mutant cells.

JAK2 is a cytoplasmic tyrosine kinase with a key role in signal transduction from multiple hematopoietic growth factor receptors. point mutation within exon 14 of the JAK2 gene (G1849T) encoding a valine to phenylalanine substitution at position 617 of the JAK2 protein (V617F) has been identified in most patients with polycythemia vera, and in about half of those with either essential thrombocythemia or idiopathic myelofibrosis. The V617F has also been detected, although infrequently, in other myeloid disorders such as chronic myelomonocytic leukemia and chronic neutrophilic leukemia. No bladder calculi is shown. There is no evidence of focal bladder wall thickening or mass. There is a pre-void bladder volume of 90 cc. There is no post-void residual shown. Right and left ureteral jets are identified with color Doppler imaging without evidence of distal ureteral obstruction.
