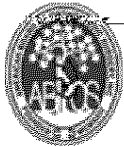

FOLLOW-UP REPORT OF A PRIMARY TREATING PHYSICIAN

Ms. Patricia is a very pleasant 58-year-old female who presents with complaint of a chronic pain in the left shoulder and knee. She continues to be employed in the capacity of the Psyche-Tech. We discussed physical therapy. She also had a MRI of the left shoulder and knee. Reports are presently pending. Ms. Patricia is seeing pain management physician who is prescribing her Norco 10 mg 60 tablets.

She is complaining of insomnia due to response to pain.

On physical examination, she is alert and oriented x3, there are no signs of sedation. Discomfort is noted on abduction of left shoulder against the gravity at approximately 95 degrees. Discomfort is noted on flexion and extension of the left knee against the gravity.

We will arrange to obtain all the records. Meanwhile, we are prescribing her Lunesta 1 mg 21 tablets. However, we highly recommend her to receive all the medications from pain management physician.

Next appointment will be in four weeks for further updates. Work status remains to be unchanged at the moment. All conditions, risks,
