FOLLOW-UP ORTHOPEDIC EVALUATION OF A PRIMARY TREATING **PHYSICIAN**

Ms. Bush is returning to our attention today for follow-up of multiple bodily complaints. Her primary concern is that of bilateral knees. She states that her left knee is greater than the right. She has difficulties with prolonged standing, and prolonged walking. She states that her left knee will swell, click, pop, and give out. She has trouble negotiating hills and stairs as well. She was seen by Dr. Nassos last year and was advised that the TKA at that time was not recommended. She does report having a follow-up appointment with her AME physician a couple of months ago. That report is not available for review. She states that in that report should be his recommendation to follow through with the left total knee arthroplasty.

Upon physical examination, the patient's gait is slightly antalgic but not using assistive devices. The left knee has a mild effusion without erythema or warmth. There is medial greater than lateral joint line tenderness. There is tenderness to palpation to the medial femoral condyle.

We will request a copy of the AME report for review. She was advised to schedule a follow-up appointment with Dr. Nassos as it has been nearly 12 months since her last visit. At this time, she states she does disagree with

his previous decision against TKA and the AME is now advising it, but she is not sure she wants to see Dr. Nassos. I have advised her a referral could be done for an outside opinion but would have to wait the copy of the AME report for verification of recommendations. She will continue her current medications on an as-needed basis. We will add a trial of Skelaxin for her spasms in the lower back pain. She will return to our attention in six weeks for reassessment and possible further recommendations.
