**ORTHOPEDIC FOLLOWUP EVALUATION OF A SECONDARY  
PHYSICIAN**

Ms. Bush is following up in clinic today regarding her left knee. She is having persistent severe pain. We requested authorization for three viscosupplementation injections, which have been authorized. She would like to start the first injection today. She does not need refill of any medications.

**PHYSICAL EXAMINATION:**

Upon physical examination of the left knee, there is no edema noted. There is tenderness to palpation over the medial and lateral joint lines and the medial and lateral patellar facets. Range of motion is zero degrees to 120 degrees. There is patellofemoral crepitus noted on flexion and extension. Quadriceps and hamstring strength is 5/5.

**IMPRESSION:**

Status post left knee arthroscopy with medial compartment chondromalacia and medial meniscus tear.

**DISCUSSION:**

I discussed additional treatment with the patient during today's visit. At this time, she would like to move forward with first GenVisc injection of a series of three for the left knee. Medications and work restrictions are being deferred to the primary treating physician. She is going to return to clinic next week for second

GenVisc injection of the left knee. She is in agreeance with the plan. All of her questions have been answered.

**PROCEDURE:**

She is willing to undergo a GenVisc injection to the left knee. The risks and benefits were discussed including infection, possibly not improving, having worsening of pain, and pseudo-septic arthritis. After discussing the risks, benefits, and alternatives, the patient did want to proceed. After informed consent and under sterile conditions, the left knee was injected with 2.5 mL of GenVisc using a 22 gauge needle. The patient tolerated the procedure well. There are no complications during or immediately following this procedure.

*We are requesting that all the patient medical records, related or unrelated to this case be sent to our attention for review which will be incorporated in accessing the treatment and medical legal issues.*
