Based on a review of the file and the reasons given in the settlement, the settlement appears fair and reasonable and is deemed adequate. The following are, if checked, applicable:


A good faith issue exists which, if resolved against applicant, would totally bar his/her recovery of workers' compensation benefits.

Release of death benefits (Sumner vs. WCAB, 48 CCC 369) has been considered.

Release of applicant's rights to ordinary benefits for injuries occurring in rehabilitation (Rodgers vs. WCAB, 50 CCC 299 and Carter, et al. vs. County of Los Angeles, et al., 51 CCC 255) has been considered.

The parties to the above entitled action having filed a Joint Compromise and Release herein, on May 31, 2022 settling these cases for \$67,500.00, and requesting that it be approved, and this judge having considered the entire record, including said Joint Compromise and Release:

**IT IS ORDERED** that said Joint Compromise and Release is approved. Award is made in favor of applicant **REGELIN CASTILLO**, against defendant **ADVENTIST HEALTH WHITE MEMORIAL, PSI** payable as follows, one lump-sum to applicant, less permanent disability advances previously made, if any, less \$4,277.07 for temporary disability overpayment by agreement and less reasonable attorney fees in the amount of \$10,125.00, payable to applicant's attorney.


